## SPEAKER AGREEMENT

### Terms

This Webinar and Speaker Agreement, Confirmation, and Recording Authorization Form (this “**Agreement**”), is dated as Presenter’s execution of the attached Cover Page which is hereby incorporated by reference.

Association of Certified Anti-Money Laundering Specialists, LLC (“**ACAMS**”) has offered, and I hereby accept the invitation to participate as a speaker at the ACAMS webinar or event identified on the attached Cover Page (hereinafter, the “Presentation”). I understand that ACAMS may revoke my invitation to present at any time in its sole discretion.

By entering this Agreement with ACAMS, I understand my responsibilities related to the Presentation, which include participating in any planning calls, preparing my Presentation (including by way of ACAMS’ preferred PowerPoint where required by ACAMS), and arranging and confirming my travel in accordance with the travel reimbursement policy as set forth in Exhibit A (if applicable).
